REMARK

The above listed products were not yet assessed for compliance with all Hygenic Aspects as stated in the Dutch Drinking Water Decree and as outlined in the "Regeling materialen en chemicaliën drink- en warm tapwatervoorziening" ("Regulation on materials and chemicals in drinking water and warm tap water supply), implemented on 1 July 2017, as specified in clause 4.2 of the Kiwa Evaluation guideline BRL-K652.

APPLICATION AND USE

The single tap and mixer taps are designed for application within following limits of use:

- a working pressure from 50 kPa up to 1000 kPa;
- a water temperature of maximum 90°C.

The recommended limits for correct operation are:

- working pressure of 100 kPa up to 500 kPa;
- water temperature of maximum 65°C.

MARKING

The Kiwa®-mark products are marked with the wordmark "KIWA" and KK in a rectangle.

Place of the mark:

- Kiwa on the body;
- KK in a rectangle on the head part.

Compulsory specifications:

- name or mark of the manufacturer KWC/Franke: on the body;
- indication of the acoustic group, if classified: on the body;
- indication of the flow rate class, if classified: on the body.

Method of marking:

- non-erasable;
- visible after assembly
