The products are intended to be applied for the making of joints in drinking water pipes of unplasticized PVC

MARKING

The products are provided with at least the following markings:

- KIWA For which is allowed for small diameters after consultation with Kiwa
- manufacturer's name/mark or registered trademark;
- "PVC";
- the nominal pressure (PN);
- indication of the field of application;
- the nominal size of the socket ends in mm;
- production period.

In case desired, the production period may be provided in code and/or on the packaging. It is preferred to provide it on the couplers/fittings.
