1. Model C201C consisting of:

wash-down WC-pan with concealed vertical outlet (USV 225), flushing cistern S201B with bottom inlet connection; with inner mechanism:

- float operated valve Geberit type Impuls 360 (FORS);
- flush mechanism Geberit type TWICO II. with dual flush operation.

3. Model C270C consisting of:

wash-down WC-pan with concealed vertical outlet (USV 225), flushing cistern HDS270 with bottom inlet connection; with inner mechanism:

- float operated Huida no. E2004;
- lush mechanism Huida no. P2232 with dual flush operation.

5. Model HDC15A consisting of:

wash-down WC-pan with concealed vertical outlet (USV 225), flushing cistern HDS15 with bottom inlet connection; with inner mechanism:

- float operated Huida no. E2004;
- flush mechanism Huida no. P2212 with dual flush operation.

2. Model C284C consisting of:

wash-down WC-pan with concealed vertical outlet (USV 225), flushing cistern S284B with bottom inlet connection; with inner mechanism:

- float operated Huida no. E2004-001;
- flush mechanism Huida no. P2232 with dual flush operation. Also supplied under the brand code no. 619121.

4. Model C284P consisting of:

wash-down WC-pan with exposed vertical outlet (UP), flushing cistern S284B with bottom inlet connection; with inner mechanism:

- float operated Huida no. E2004-001;
- flush mechanism Huida no. P2232 with dual flush operation. Also supplied under the brand code no. 619122.

6. Model HDC201NC consisting of:

wash-down WC-pan with concealed vertical outlet (USV 225), flushing cistern HDS201D with bottom inlet connection; with inner mechanism:

- float operated Huida no. E2004;
- flush mechanism Huida no. P2212 with dual flush operation.

Application and use

The WC-pans delivered under this certificate in combination with flushing cisterns and/or pressure flush valves are intended for use as sanitary appliances, connected to drinking water installations with a water temperature of 30 °C maximum.

Marking

The Kiwa®-mark products are marked with the wordmark "KIWA". The WC pan, cistern and float operated valve of the close coupled suites are marked with the wordmark "KIWA". On the WC-pan this wordmark shall be followed by the number 6, 7.5 or 9, indicating the flushing volume.

Example:

Close coupled suite marked as follows: WC-pan: "KIWA-6"

WC-pan: "KIWA-6" Cistern: "KIWA" Float valve: "KIWA"

By this marking it is given that the close coupled suite is Kiwa certified and intended for use with a full flush of 6 \pm 0.2 litres. This flushing volume is indicated by the highest waterline in the

cistern.

Place of the mark:

- on the WC-pans between the attachment holes of the lavatory seat or on the sides;
- on the float valves on the body;
- on the cisterns on the left side, right side or front or on the inside above water level.

Compulsory specifications:

name or mark of the manufacturer

- on the WC-pans between the attachment holes of the lavatory seat or on the sides;
- on the float valves on the body;
- on the cisterns on the left side, right side or front or on the inside above water level.
- reference to the European standard EN997

Method of marking:

- Non-erasable;
- · visible after assembly.
