Fitness for contact with drinking water

These products are approved on the basis of the requirements for hygienic aspects set in the "Regeling materialen en chemicaliën drink- en warm tapwatervoorziening" ("Materials and chemicals in the supply of drinking water and warm tap water Regulation" dated 01-07-2017; published in the Government Gazette).

MARKING

The Kiwa®-mark products are marked with the word mark "KIWA [™] .

Place of the mark: on the hose.

Compulsory specifications:

- digits indicating the month and year of production (MM/YYYY).

Method of marking:

- non-erasable;
- legible;
- one full set of marks applied at each 250 mm (maximum) of length of hose.

APPLICATION AND USE

The products are intended to be used as inner hoses of flexible connecting hoses as meant in the Kiwa evaluation guideline BRL-K622 "Flexible connecting hoses". These flexible connecting hoses are designed for using in drinking water installations with a maximum water pressure of 1000 kPa and a maximum water temperature of 70 °C.
