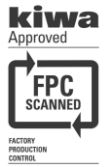

Connection:

- ½" male gas thread ISO 7 and ½" female swivel straight or with elbow connection.
- ½" internal thread and bayonet connection.

Gas hose length: 500, 750, 1000, 1250, 1500 and 2000 mm
