### APPLICATION AND USE

Shower hoses for sanitary taps according to EN 1113 are intended for application in drinking water installations with a dynamic pressure of 50 kPa to 500 kPa and a maximum water temperature of 70°C.

The recommended limits for correct operation are a dynamic pressure of 100 kPa to 300 kPa and a maximum water temperature of 42°C.
