# Fitness for contact with drinking water

- · nominal outside diameter of the corresponding pipe in mm;
- production code.

Location of the marks: on every fitting.

The realization of the marks is as follows: clear, durable and indelible.

The smallest packaging unit of the fittings are provided with at least the following information:

- ◆ KIWA
- manufacturer's name, trade name, system name, logo
- certificate number of the accompanying technical approval (system) certificate, in accordance with the marking of the connecting pipe;
- material identification if the fitting body is made of plastics;
- nominal outside diameter and nominal wall thickness of the corresponding pipe in mm;

Location of the marks: on every package.

The realization of the marks is as follows: clear, durable and indelible on every packaging.

# **APPLICATION AND USE**

The products are designed for drinking water installations with a lifetime of 50 years at an operating temperature profile according to class 2 of ISO 10508 and an allowable working pressure of maximum 8/10 bar.
